Board President Daniel Giannelli opened the meeting at Noon with the Pledge of Allegiance to the United States of America.

Approval of Agenda

Approval of Minutes

Committee Reports

<u>Finance Committee</u> At the request of Finance Committee Chair David Hallman, Jr., James Pacansky gave the Finance Committee report. He stated that the Finance Committee met on September 24, 2024. Mr. Pacansky reported that the

committee reviewed the cash forecast, August financials, bills to be paid, capital fund transactions, and expense reports. Mr. Pacansky stated that the Finance Committee recommended at the meeting the approval of the bills. Ryan Bergquist made the motion for approval seconded by Aaron Susmarski. Approved by Yeas: Aaron Susmarski, Erin Kerner, Daniel Giannelli, Eric Rogers, Brian Slawin, Dorothy Smith-Frazier, and Ryan Bergquist.

Financial Report- James Pacansky reported a deficit of \$79,137 for the month of August bringing our year to date deficit to \$745,859. We are favorable to budget \$18,554 with revenue unfavorable \$75,960 and expenses favorable \$94,514. Mr. Slawin thanked Mr. Pacansky for his reporting. He commented that he is pleased to see how healthy our reserve fund remains and how we have been able to reduce our CPE (cost per emplaned passenger). Mr. Giannelli stated that he is unable to participate in Finance Committee Meetings for the remainder of the year and has asked Mr. Slawin to participate in his place.

Resolution 2024-12 Authorize Executive Director to Accept and Execute FAA Grant Offer- Derek Martin explained that this is for work on Taxiway A. The bid was awarded by this Board in 2023 with the work being done with this summer.

Mr. Martin added it is voluntary for airport visitors to participate in the Title VI survey. He added that we are working on finalizing and implementing our survey with AirVote.

RESOLUTION 2024-14

Erie County Council liaison Charlie Bayle thanked the Authority for their efforts to expand service. He is excited about the opportunities with Breeze Airways. Mr. Bayle stated that the County does plan to meet with the Erie Chamber regarding the Fly Erie Fund.

Erie City Council liaison Chuck Nelson reported that the City of Erie has committed \$100,000 to the Fly Erie Fund.

Board Member Comments

Mr. Slawin congratulated fellow Board Member Erin Kerner for the significant grants her new business acquired.

Eric Rogers stated that his new employer is able to accommodate remote participation for Authority meetings, so he plans to continue his position on the Board. Mr. Giannelli stated that he never accepted the resignation of Mr. Rogers from the last meeting anyways!

Executive Director's Report

Mr. Martin reported/shared the following:

- We are working with a company called AirVote to incorporate some of the Harmonic customer service survey items into an opportunity for airport visitors to share feedback on their ERI experience (real time feedback).
- Our ERI letters have been installed in the baggage claim area. We plan to "reveal" the letters on social media in conjunction with the new Breeze service.
- We continue to drive down CPE. American Airlines is currently at \$10.03 and was 15 passengers away from a CPE of \$9.99!

- The Board will be invited to the inaugural Breeze flight on November 6th. We have a water cannon salute planned to celebrate the first flight. More information to follow.
- We hosted an On Board with Autism event in August in partnership with TSA, American Airlines, and Autism Society-Northwestern Pennsylvania. It was well received and gave families living with autism a real life airport/air travel experience. The TSA, American Airlines, and Authority staff that participated all volunteered their time for this worthwhile event and the families that attended were appreciative.
